GENERAL EDUCATION LEARNING OUTCOMES ASSESSMENT: ORAL COMMUNICATION (OC)

RUBRIC DATA FOR OC FOR AY2018-19

During Fall 2018 and Winter 2019, the General Education Oversight Committee (GEOC) began the process of data collection in OC courses in order to assess the new General Education Program. Oral Communication (OC) has had a well-developed set of assessment criteria, and thus was selected as one of the first areas for review in this process. Below is a brief overview of the results.

SCORING

Faculty scored speeches from a total of n = 596 students in COM 1010 courses in Fall 2018 (n = 199) and Winter 2019 (n = 397). Two speeches for each student were scored from 0-4 using a rubric of the criteria within two of the eight OC learning outcomes (see Appendix). Those scores correspond to General Education's four-point scale as follows, with scores rounded to the nearest whole number:





Figure 1 is the distribution of average student scores across the informative and persuasive learning outcomes for OC. A large majority of students scored "moderate" or above across both outcomes.

Overall, results indicated a large percentage of students in the OC courses demonstrated a learning performance at the "moderate" level or higher. Figures 1-3 display the results for the learning outcomes for informative and persuasive speech and a composite of these learning outcomes for OC.

It should be noted, data were not collected for each individual OC learning outcome due to the Communication Department's misunderstanding of what data needed to be collected for assessment of the OC designation. This misunderstanding has been resolved, and separate learning outcome data will be collected for each of the learning outcomes in subsequent assessments.

COMPOSITE RESULTS




Oral Communication Informative
